Business Days Flow Chart from Start to Finish

- **Day 1:** Complete Management Consulting Worldwide contract and payment.
- **Day 2-6:** You do absolutely nothing. During this time we will be doing all the work setting up the professional LLC, virtual office, a business phone, business email, professional multi page website, EIN acquisition, application BOI Report, DUNS number and a lot more.
- **Day 7-8:** You will receive an email from MCW containing PDF's attached and links. Save them, especially the PDF containing the information about your new LLC. Many times over the upcoming months and years you will need to refer to this information.
 - 1.) We set up your professional business email account, however, you need to follow instructions on the LLC information PDF to send us your desired Password so you can access your email account.
 - 2.) Included in this email are instructions on completing the new contract and credit card form to provide to the company who is responsible for creating your net 30 accounts and credit applications. This must be accomplished within 2 business days.
 - 3.) You now must open a business bank account in the exact name of the new LLC. For your convenience, we have provided a link online to open an online bank account This business account has no minimum monthly balance requirements, no monthly fees. Or, you can set up any business bank account yourself matching the exact name of your new LLC, but you must have an open business bank account immediately. Follow the instructions on PDF titled, Business Bank Account Setup Process.
- **Day 9-10:** Complete the contract and credit card form to establish net 30 accounts. Complete opening bank account, complete sending an email password, all these items must be returned by email within 2 business days.
- Pour 11-13: You need to register your company with a few free online sites so net 30 and lending institutions can verify you are really a business. Refer to the PDF sent you titled, Establishing More Visibility for Your Funding Options to See You. If you do not do this immediately, you will receive a much smaller amount or NO funding if they feel your company is not real. Please remember if you purchased more than one LLC, all these steps must be accomplished per each LLC entity.

Day 14-90:

Check daily your business email and answer all incoming calls from your area code 307 business line. Often net 30 accounts and lending institutions send email, call or both to verify you are a human, not A.I. or a terrorist. During this time the Net 30 accounts will be established, products / services will be purchased on your behalf and your LLC credit score will start to increase. Within approximately 3+ months your LLC business credit score will be high enough to apply for funding from various funding institutions.

Days 315+:

You will be responsible for renewing annual LLC renewal fees, and keep the LLC information updated and within compliance. MCW will help clients renew annual fees, web hosting yearly fee, registered agent annual fee and annual registrant services fees. When your Wyoming LLC is approximately 45 days before expiration, MCW receives notification of renewals are due. We will then send you an invoice to complete all the renewals at this time to keep your LLC active and within compliance. You are responsible for providing to MCW any changes to ownership or contact information prior to the annual updating. Read and execute the items listed on the PDF sent to you with your new LLC information a few days' prior. Refer to our PDF entitled, Continual operation of a Wyoming LLC within Compliance.
